I write to give you formal notice of the imminent public launch of a documentary webpage titled:

“The Judiciary Exposed: When Oversight Collapses”

This communication is **not a threat** and **not an attempt at negotiation or extortion**. It is a courtesy notification that the page exists, has been substantially finalised, and will be publicly launched within the next day or two as final technical and layout adjustments are completed.

The page is a structured archive built entirely on primary documents that have, over many years, been directed to various organs of state, including but not limited to:

- Complaints and correspondence to the JSC and JCC.

- Letters and emails from senior judges and judicial leadership in the Gauteng Division, Pretoria.
- Complaints to SCOPA and other parliamentary oversight bodies.
- Public statements and articles by judicial and political office-bearers concerning accountability in the judiciary.

The content does not rely on speculation or anonymous allegations. It consists of court documents, orders, rulings, complaint forms, official letters and email trails generated by the very institutions listed above. The page simply places those documents in one public, accessible record and explains the contradictions and systemic failures reflected in them.

This Judiciary page is expressly identified as the **first release** in a broader series of disclosures that have already been compiled and archived. Further chapters focus on, among others:

- The NPA and the NDPP,
- SAPS,
- SCOPA and Parliament's oversight structures,
- The Speaker of the National Assembly,
- The President and the Presidency,
- CSOS adjudication and enforcement failures,
- The LPC and other regulatory bodies.

These additional chapters already exist in the back-end of the website and are preserved independently. Their publication does not depend on any further action from me personally.

A central focus of this first chapter is the way in which the Pretoria High Court Division and associated oversight bodies have treated me as a lay litigant over a period of years:

- punitive costs orders imposed against a self-represented party,
- refusal or obstruction in respect of leave to appeal, records and transcripts,
- contradictory directions from judicial leadership, and
- the effective denial of appropriate consideration of complaints by the JSC/JCC on jurisdictional grounds that are themselves contradicted by the legal framework and prior rulings.

I assert my right, under the Constitution, to publish this material in the public interest. This includes the right to freedom of expression and to receive and impart information, as well as the right of the public to oversight over organs of state that exercise public power and control access to justice.

To avoid any doubt:

- I am not asking for money, favours, settlement, or any form of benefit.
- I am not threatening any person or institution.

- I am placing you on record that the material exists, has been preserved, and will be made available for public scrutiny.

If any organ of state wishes to point out a **demonstrable factual error** (for example, an incorrect date, case number, or misattribution of a document) accompanied by documentary proof, I am willing to consider such corrections in writing. However, the decision to publish, and the timing of publication, is not contingent upon a response to this email.
