Dear Mr Cameron,

I address this correspondence to you under conditions of strict confidentiality as a protected whistleblower disclosure. Given the nature of the matters raised, the attached documentation, and the current national context, I ask that this communication be treated with the seriousness, discretion, and urgency it warrants.

Attached you will find my formal letter addressed to you, together with a limited selection of supporting documents. These attachments are not exhaustive. They are provided deliberately and conservatively as **proof of record**, not as a complete evidentiary disclosure. They include, among others, correspondence between myself and the DPCI, as well as the letter that I only received in December 2025 confirming that the National Prosecuting Authority had already decided in 2021 not to prosecute — a decision that was never communicated to me at the time, despite my status as a protected witness.

I wish to make it clear that the underlying evidentiary material, including financial documentation and related records, forms part of the official investigation docket held by the Hawks and the DPCI. My

disclosures to Parliament are therefore not speculative and are anchored in material already obtained, assessed, and retained by law-enforcement authorities. I further record that I retain duplicates and corroborating material consistent with my position as a whistleblower, should verification or clarification be required.

I am not seeking sympathy, nor am I seeking another acknowledgment of receipt. I have already received acknowledgments in the past, followed by silence. That approach is no longer acceptable. I am formally demanding substantive answers, on the record, to the issues raised in my attached letter — specifically the failure to act on my disclosures while I was under Witness Protection, the unexplained termination of that protection, and the NPA's decision-making process in declining to prosecute without requesting further evidence.

I am taking a deliberate and informed risk by sending this correspondence again. I did so in 2018 and 2019 and was not believed. I am doing so now because the current parliamentary processes, arrests, and public admissions confirm that the warnings I gave years ago were neither imagined nor exaggerated. Had they been acted upon at the time, the country would not be dealing with the scale of institutional collapse now unfolding.

This email, its attachments, and any further disclosures I may make are submitted in the public interest and under my constitutional rights to freedom of expression, inquiry, and participation. I expect engagement, accountability, and answers — not silence.
